#### 1. Call to Order and Approval of Agenda

#### 3. Business Arising from Previous Minutes

#### a. <u>Rep Jerseys & Branding Update</u> – President

- President provided an update on the email sent April 17<sup>th</sup>, where he proposed a vote on jersey colors and logo preference. As previously communicated to the President, by HNS, a black and red jersey set would not likely be approved by Minor Council, given difficulties experienced this season with teams not having a 'light' jersey. Eleven board members voted in favour of "black and gray" rep jerseys; seven board members voted for "black and white." Regarding the logo for the jerseys, seven board members preferred the existing shield; eight members voted for "BEARCATS" diagonally across the front of the jersey, while three board members voted in favour of the two options.
- Discussion ensued.
- Motion by 2<sup>nd</sup> VP to order two new sets of jerseys for each of the rep league teams. Black
  jerseys will maintain the existing shield, and the gray set will have "BEARCATS" diagonally across
  the chest, per the branding document that was circulated. Motion seconded by 1<sup>st</sup> VP. One
  counter minded vote. Motion approved.

  - 2<sup>nd</sup> VP shared draft version of the "Year-End" Google Form, for comment.
  - Action: 2<sup>nd</sup> VP to email Google Form to membership for their year-end feedback.
